## 5-State Breeders Barrel Maturity Rules

*\$7,000 added and a saddle to the winner*

*\$2,000 added Cass Equine 2D Incentive with no additional fees, JJS buckle to the champion*

1. To be eligible for the 5-State Maturity horses must be registered and must be sired by: a 2018 5-State Stallion or 100% paid in any previous 5-State Breeders Barrel Futurity or Maturity. Horses may also be eligible based on stallion eligibility during their birth year - contact the 5-State regarding those eligibilities.
2. Horses four and under are not Maturity eligible and horses may not enter the Futurity and Maturity in the same year.
3. There will be two go-rounds.
4. Entry Fees will be \$150.00, of which \$40.00 is an administration charge.
5. The Division of the Purse will be:  
25% to the First Go-Round  
25% to the Second Go-Round  
50% to the Average
6. NOMINATION FEES:  
**\$75.00 due June 1**  
**\$75.00 due July 1**  
**\$150.00 TOTAL NOMINATION FEES**
7. Late nominations/sustaining payments MUST BE PAID BY JULY 2nd, 2018.  
**LATE NOMINATIONS/PAYMENTS are \$25.00 per late payment. Total entry fee after July 1st is \$200.**
9. Futurity Rules & Regulations will apply to the Maturity as stated in the Futurity rules above where deemed appropriate.

## 2D Maturity Incentive sponsored by Cass Equine

1. There will be \$2000 paid out to a 2D incentive. The maturity 2D will be a 0.75 second split. There are no additional entry fees beyond the Maturity entry fee.
2. Money will be divided between the first two rounds. No average payout.
3. A Jessie Jaymes Silversmiths buckle will be awarded to the 2D Maturity Average Champion (1.5sec split).
