5-State Breeders Youth Breakaway Roping Rules

1. All Decisions made by the 5-State Breeders Futurity are final. We reserve the right to refuse entry to any horse or individual. No discrimination will be tolerated.
2. The Youth is open to horses registered and sired by a 2025 5-State Stallion or a stallion previously paid in to the 5-State in the year the horse was born. Horses paid into a previous Futurity or Maturity event at the 5-State are eligible. The horse must be ridden by a youth age 13 & under as of January 1, 2025.
3. There will be two go-rounds in the 5-State Breeders Youth Breakaway Roping. Total time of the two go-rounds will determine determine the Championship Standings and winner of the 1st place award.
4. The Youth Breakaway Roping will be paid on a progressive payout with a two second split in the 2D in each round provided there are 10 contestants. If less than 10 contestants, the Youth will be a straight payout. All added money and entry fees will be paid out.
5. The division of the purse will be 50% to each round. Awards to the Championship Standings (average).
6. Nomination Fee: \$75.00.
All entries must be postmarked by June 17th, 2025. Late entries will be taken by jotform only until 5pm July 1st, 2025 with a \$25 late fee.
Buyouts will be taken ONLY on entries paid in full and can only be done between June 17th and 5pm July 7th, 2025. Buyout Form (via jotform) and \$25 buyout fee must be submitted to LI Productions by 5pm July 7th, 2025. Entry fees are to be exchanged between the two parties and are not the responsibility of the 5-State Office or LI Productions, LLC. Payments made with insufficient funds checks will incur a \$20 fee in addition to any late fees.
7. A photocopy of the front and back of the registration papers of horses must accompany the nomination.
8. It is recommended to have all paperwork required to travel across or to South Dakota (health certificate, Coggins, and brand inspection). All horses stalling on the Central States Fairgrounds must have a current health - they check it when you stall. All horses staying overnight on the grounds must be stalled.
9. In order for time to be given the loop must pass over the calf's head - after that will be catch as catch can.
10. All decisions made by the judge and/or committee are final.
11. An electric eye barrier will be used.
12. Checks will not be issued without a current W9 on file. W9 must be on file by December 31, 2025 or winnings will be forfeited.
