### **5-State Breeders Pole Bending Futurity Rules**

#### \$500 added and prizes

- 1. The Futurity is open to horses that are four or five years old. Horses may not have reached the age of six by the time of Futurity. Horses must be registered and sired by a 2025 5-State Stallion or a Stallion previously paid into the 5-State the year the futurity horse was born.
- To be eligible for the Pole Bending Futurity, the horse may NEVER have competed in ANY pole bending including AQHA shows, playdays, novice horse events, futurities or derbies, rodeos, etc. prior to November 15, 2024. To do so means forfeit of any and all fees paid and elimination from the futurity. Horses may have competed anywhere after November 15, 2024. Horses may have been entered in other events.
- 3. All riders must be designated on or before by July 1<sup>st</sup>, 2025. Rider changes after that date will need to submit a RIDER CHANGE form (via jotform) along with the \$20 rider change fee.
- 4. There will be one go-round.
- 5. Entry fee will be \$70.00 of which \$20 will be withheld from each entry for an administration fee and one exhibition. Pre-entries close on June 17<sup>th</sup>, 2025.
- 6. Late entries will be accepted until 5pm on July 1<sup>st</sup>, 2025 via jotform with a \$25 late fee. Buyouts will be taken ONLY on horses paid in full and can only be done between June 17<sup>th</sup> and 5pm July 7<sup>th</sup>, 2025. Buyouts are done via jotform and \$25 buyout fee must be submitted to LI Productions by 5pm July 7<sup>th</sup>, 2025. Entry fees are to be exchanged between the two parties and are not the responsibility of the 5-State Office or LI Productions, LLC.
- 7. The Pole Bending Futurity will be paid on a progressive payout with a 1.5 second split.
- 8. A photocopy of the front and back of the registration papers must accompany the nomination.
- 9. Payments made with insufficient funds checks will be assessed a \$20 fee in addition to any late fees.
- 10. Checks will not be issued without a current W9 on file. W9 must be on file by December 31, 2025 or winnings will be forfeited.
